SHOW COMMITTEE: The show committee reserves the right to cancel or split classes; limit class size; change arenas; limit the number of rides & number of horses per rider; and cancel or add judges. The show committee also reserves the right to refuse any entries. Every horse entered for competition will comply with the rules of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be condition of entry that each exhibitor shall hold this horse show and the officials and employees of the show blameless for any loss or accident to his horse, employees, equipment, which may occur from sickness, fire or otherwise.

Each competitor is responsible for supplying the show management with the correct and required association numbers of RMDS, USDF and/or USEF for the horse, owner, rider, coaches, and trainer, before the day(s) of the competition. The scores of competitors who fail to supply correct numbers may not count towards regional or national awards. The proof of these numbers must be in the form of either their actual membership/registration cards or a facsimile of them. Proof of membership must be included with entry form. Please provide the USEF/USDF Master Verification (www.eqverification.org) although membership cards or photocopies of cards are still acceptable. Failure to provide proof of USEF and/or USDF membership will result in competitor being charged non-member fees. Members that are unable to

produce the USDF memberships cards/registrations or a facsimile will be asked to sign an affidavit and pay an affidavit fee. All entries are taken on a first come, first served basis. Some shows return late arriving entries after the show is filled, and some shows place entries on a wait list on an as-received basis. Please check each show for any additional policies. Send in the entries as soon as possible to assure entry to the show. **Only one horse-rider combination per entry form.** No exhibitor may withdraw horses from a licensed show after it has commenced, or remove them from the show grounds without permission of the show secretary.

ENTRIES: Accepted on first come, first served basis, based on (readable) postmark. Post entries (postmarked after closing date) will be accepted on a space available basis with late fee. Once the competition is filled a wait list will be established. Wait list will be maintained through July 19, 2019. Current 2019 RMDS entry form must be used. Proof of memberships and horse registrations must be included with entry, including RMDS memberships if an RMDS member. **ALL COMPETITORS MUST SUBMIT WITH THEIR ENTRY CURRENT PROOF (WITHIN 6 MONTHS OF THE FIRST DAY YOUR HORSE ENTERS THE COMPETITION GROUNDS) OF EQUINE INFLUENZA AND RHINOPNEUMONITIS VACCINATION FOR ALL HORSES 7 MONTHS OF AGE OR OLDER. A CURRENT HEALTH CERTIFICATE AND COGGINS MUST ALSO BE SUBMITTED.** If entry is incomplete, horse/rider combination will be placed on the wait list until required paperwork is received. Enter online at www.horseshowoffice.com.

Times: provisional times available at www.2whitefeet.com and emailed to readable, valid email addresses. Official times will be posted at the show office by Noon the day before the start of each show. Numbers required all times when horse is outside of stall or not tied to a trailer. Entry required if schooling only (schooling fee and appropriate stabling fee required). Anyone not appearing for any of their dressage tests without prior notification to the show secretary will be “scratched” from their remaining classes. Those rides will be filled if possible.

Freestyle entries: Except for USEF/USDF Championship classes and for FEI Pony Riders, FEI Junior, FEI Young Rider and FEI Para-Equestrian Freestyles, in order to enter a freestyle class at any level, a horse/rider combination must have received a minimum score of 63% in the highest test of the declared freestyle level or any test of a higher level at a Federation Licensed or FEI recognized Dressage Competition or “open” Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. A photocopy of the test verifying eligibility, or copy of the USDF score verification, must be submitted with the entry for a freestyle class. Effective 12/1/18. Freestyle sound checks will take place on Saturday morning at 7:30 AM. Other times may be arranged with prior consent by the show secretary or show announcer.

Any person wanting **pony measurements** must contact the show secretary before the show to set a measurement time – we will tentatively measure ponies at 4 pm on Friday but other times may be arranged. There may be a fee of no more than \$100 per pony associated with measurement.

Beginning in the 2016 competition year, which began on October 1st, 2015, participants and horses competing in **Para-Equestrian** classes at USDF recognized competitions will no longer be exempt from USDF memberships. Para-Equestrian competitors will now be required to have a USDF Group Membership, a USDF Participating Membership or a USDF Non-Member ID and pay the \$35 Non-Member fee per competition. Owners of horses competing in the Para-Equestrian classes will be required to have a USDF Participating Membership, a USDF Business Membership, a USDF Group Membership or a USDF Non-Member ID and pay the \$35 Non-Member fee per competition. The horses competing in Para-Equestrian classes will be required to have a USDF HID number or be USDF Lifetime registered.

REFUNDS: All Cancellations must be made in writing either by email, fax or mail. Up through closing date, all fees refunded except office fee. From day after closing to day prior to competition, class fees will be refunded only if ride(s) can be filled from wait list. Stabling not refundable after closing date. Qualifying fees and drug fees (if horse is not on show grounds) refunded. Qualifying fees also refunded if scratched before ride and requested to be refunded, otherwise forwarded to USDF or applied to other indebtedness. During competition days **no refunds including for Acts of God. Office fee is never refundable.**

ARENAS: All tests will be ridden in an indoor standard 20 x 60 meter arena with sand footing. Warm-up area is a large outdoor sand and pea gravel arena. Lunging is in sectioned off area of outdoor arena with separate gate entry. Arena photos are available at onthebitdressage.com (under *Events*) Arenas watered and worked throughout show. **Show arena open for schooling Friday after set up, approximately 1pm, and throughout show after classes are complete until show office**

closes. USEA Eventing Tests and Para Equestrian tests may be in 20x40 or 20x60 depending on number of entries and level of test entered.

AWARDS: Prize & ribbon to first place; ribbons through 6th place. High Point Awards. There will be no awards ceremonies, so participation is not required.

STABLING: Outdoor private runs with run-in sheds are available on show grounds. The outdoor runs with sheds can be provided with shavings (larger shavings, so the wind doesn't blow them away right away, both the shed and the run are covered with shaving), otherwise it is just dirt ground. \$30/night without shavings, \$45/night with shavings. There are also very very limited indoor stalls with runs attached, but the door can be closed. \$50/night. Stalls are 10x12, solid walls, full doors with solid bottom and bars on top half. These will be allocated on a first come/first serve basis. EMT: Steve Kaiser - On site 45 minutes before start of show through completion of all classes.

Opportunity Classes: Opportunity classes are for those wishing to participate in a recognized show experience but who do not wish to participate in USEF/USDF award programs. Participants and horses do not need USDF/USEF memberships and do not pay nonmember fees. At these shows horse/rider combinations may cross-enter into recognized classes with appropriate USDF/USEF memberships or non-member fees.

CONCESSIONS: Food truck with breakfast and lunch options on site.

HOTELS: A block of rooms have been reserved at the AmericInn, 4712 E Grand Ave., Laramie, under On The Bit Dressage and are available for Friday, July 19 and Saturday, July 20. Reservations can be made by calling the hotel directly at (307) 745-0777 by July 10th for the discounted group rate.

DOGS All dogs must be on a leash at all times. No dogs are allowed in the indoor arena, including viewing/lounge area or in the warm-up arena. Dogs must have copy of current vaccination records and health certificate. Non-compliance may result in USEF penalties.

DIRECTIONS: From I-80: Take Exit 313 for US-287/3rd Street towards Ft. Collins, CO. Head South. Turn Left onto Skyline Road (the turn is before you go over the viaduct – just after the onramp to I-80 towards Cheyenne). Drive .3 miles and turn Right onto Soldier Springs Road. Drive .4 miles. Turn Left into Spur Ridge Equestrian Community (white vinyl fence before you turn). Proceed up the hill to indoor arena and horse facility.

From Highway 287 (Fort Collins): As you come into Laramie, you will pass the Port of Entry and Albany County Fairgrounds. You will go over the viaduct (train tracks below) and there is a Ramada hotel on your right. At the bottom of the viaduct, you will turn right onto Skyline Road. If you go under I-80, you've gone too far. Drive .3 miles and turn Right onto Soldier Springs Road. Drive .4 miles. Turn Left into Spur Ridge Equestrian Community (white vinyl fence before you turn).

Proceed up the hill to indoor arena and horse facility.

Motorized Vehicle Statement

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the

device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

Sharps Containers are located throughout the barns and one is also available in the show office. Please use them appropriately or fines will be assessed per USEF guidelines. In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, bio-hazardous medical waste containers will be provided in the stable area. All exhibitors and their agents are responsible for the proper disposal of this waste.

Starting January 1, 2019, if you are a USEF Competing Member 18 years of age or older you are required to complete the core Safe Sport Training within 30 days of activating your membership.

If you do not complete the training, you are ineligible to participate in all USEF activities including competitions.

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.) Individuals cannot compete at a USEF-licensed/USDF-recognized competition with a USDF Education Membership.

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Education Membership (EM): A membership issued to an individual directly by USDF. This online education only membership expires 12 months after the date joined. This membership type does NOT allow an individual to compete at a USEF-licensed/USDF-recognized competition.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form and fax or mail it to the USDF office.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.



2019 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at www.usdf.org. Please refer to the 2019 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

- Must have a USDF Participating* Membership (PM).
- Must have a USEF membership (Junior Active, Senior Active, or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s) of record. A horse is not required to have breed registry papers.

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Junior Active, Senior Active, Life, or Recorded Farm (with Active Farm Owner)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership **and must be the owner of record with USEF and USDF**. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

Minimum Qualifying Scores: One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division. Freestyles have only open divisions.

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class will be held in

conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

- a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.
- or*
- b) Qualified to compete in any regional dressage championship class (excluding freestyles).

Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

The construction and application of RMDS rules are governed by the laws of the State of Colorado, and any action instituted against the RMDS must be filed in the State of Colorado.
